This request to amend has been made by Northeast Asphalt on behalf of one of the subcontractors who is seeking payment above and beyond the contractual amount.

B. DISCUSSION AND ACTION - Contract with Fair Market Assessments, Inc, for Revaluation

This contract proposal is for a "market adjustment" revaluation to be completed for 2020. According to the Assessor, it is the same as a complete revaluation excluding the on-site inspections. Based on the information they have on file and considering the current selling prices of similar properties, they would establish a new assessed value for 2020 that would be at current market values. They would assess each parcel individually and would also take updated photos to be attached to the existing records. The estimated cost (\$60,000) would be included in the 2020 Capital Projects budget.
